The Head Lama and President of TNMC is also the President of the Board of the Bodhgaya Religious Trust. The assets of the Bodhgaya Trust are all in a Vanguard account. The Vanguard account manager had discussions throughout the year with the Treasurer and or the Board President concerning the asset allocations, policies, and performance of the account. Monthly statements and quarterly performance reports were sent to the Treasurer and the office of the Head Lama of TNMC. The Head Lama met with members of the Board in an annual ongoing detailed planning and budgeting of the upcoming ceremony. After completion of the ceremony, a report was made reconciling the budgeted and actual expenses for the current year's ceremony. Any carryover funds are accounted for and deposited with the ceremony committee of monasteries in India for use the following year. Head Lama oversees these budgets and reports and shares them with the Bodhgaya Trust Board. Signatories on the Vanguard account are all members of the Bodhgaya Trust Board.

The supported organization is the Head Lama of the Tibetan Nyingma Mediation Center (TNMC), a church. The mission of TNMC is to support, preserve, protect, and further the religious Buddhist traditions of Tibetan Buddhism, particularly the Nyingma school. In the furtherance of this mission, in December of 1989, TNMC founded an annual World Peace Ceremony at the site of the Buddha's enlightenment in Bodhgaya, India. During that founding ceremony, 500 Nyingma practitioners from throughout the Himalayan regions came to Bodhgaya to gather in prayer for world peace; religious texts produced by the TNMC Yeshe De Project were distributed for free to those in attendance. At the end of the ceremony, the leaders of the various monasteries decided to hold the ceremony yearly and asked TNMC for help sponsoring it. TNMC

established the Bodhgaya Trust in 1993 in response to its commitment to support the annual Nyingma ceremony. To date, the ceremony has been held every year since 1989. Please note that the trust is a church auxiliary. The exempt purpose of the supported organization, The Tibetan Nyingmapa Meditation Center, ("TNMC") is the preservation of the Tibetan Culture and Buddhism as a living tradition. The preservation of the Buddhist tradition is dependent on the religion being transmitted from generation to generation. Three key elements of the preservation of Buddhism are practice and ceremony, support of monasteries and practitioners, and the texts which contain the teaching of the Buddha and the subsequent great teachers and masters. One of the pillars of the text transmission is accomplished by the TNMC Yeshe De Text Project production and free distribution of Buddhist texts to the Tibetan communities in Asia. This distribution takes place annually at the Bodh Gaya ceremony where over 8,000 monastics and lay people of all ages assemble in prayer. The Bodhgaya Trust sponsors this gathering on behalf of TNMC.

The sole activity of the Bodhgaya Religious Trust is to support the Bodh Gaya Ceremony on behalf of its supported org....Therefore in 2019 and every year, all of its activities are in furtherance of the exempt purpose of TNMC. Since this activity is completely integral to the exempt purpose of TNMC, TNMC itself would directly support the annual ceremony in Bodh Gaya if it had not established the Bodhgaya Trust as a church auxiliary and if the Bodhgaya Trust was unable to do so.
