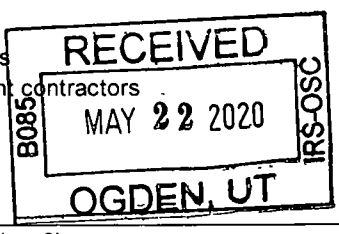



- Higher Orbits for their Go For Launch program

The Foundation, via its General Atomics Scientists/Engineers Supporting Science/Engineering for Students (GASSSS) program, supported over 150 engineers and scientists to perform science and engineering activities in classrooms or at after school activities or at General Atomics facilities and to reimburse them for science and engineering materials that they purchased and provided to those schools or activities. These activities ranged from giving science and engineering demonstrations to students, assisting teachers with science and engineering lessons, mentoring high school robotics clubs, or providing support to regional science and engineering competitions such as science fairs and science olympiads. On average, each of these activities involved about 50 students, so approximately 7500 students were involved in these science and engineering enrichment activities. All engineering presentations and curricula that were developed by these scientists and engineers were posted on the Foundation web site for others to use. In addition, all of these activities were documented and posted on the Foundation web site so that other scientists and engineers had points of contact and examples of potential activities.

The General Atomics Sciences Education Foundation provided financial support for the Innovations for Learning, Inc. TutorMate literacy program in Santa Ana California first grade classrooms where 27 General Atomics employees provided on-line tutoring of students in reading and science during the 2018-2019 and 2019-2020 school years

The Foundation also supported General Atomics employees to provide support to the local community. For example, the Foundation recruited and support multiple employees to judge at the San Diego 2019 Future Cities Competition, supported employees to act as mentors to UCSD students involved in the COSMOS program, and helped recruit and support employees to act as mentors and guest speakers to high school girls participating in the Elementary Institute of Science Girls Take Flight program

The Foundation also judged and provided awards at the 2019 Greater San Diego Science and Engineering Fair.
