 Provided 17 water projects within the state of Andhra Pradesh, between the Visak and East Godavari Districts. These projects were taken up by our indigenous partner, Society for Helpless and Economically Backward Areas (SHEBA). The impact of the water projects in these 17 places is estimated at 12,000 rural men, women and children. In addition to the water projects, funding was also provided to assist in the construction and completion of a dining hall and kitchen project at New Life Children's Home which is operated by SHEBA and provides care for 220 orphan and semi-orphan children

4b (Code:) (Expenses \$ 47,307 including grants of \$ 38,649) (Revenue \$ 0)
 Provided 15 water projects within the state of Tamil Nadu, primarily within the Trichy District. These projects were taken up by our indigenous partner, Depressed People's Welfare Association (DPWA). The impact of these 15 water projects is estimated at 11,000 rural men, women and children. In addition to the water, financial assistance was also provided for the repair and remodel of a roof for a school building which provides education for elementary age children.

4c (Code:) (Expenses \$ 50,171 including grants of \$ 55,049) (Revenue \$ 3,088)
 Provided 7 water projects within the states of Gujarat and Maharashtra through our indigenous partner, Ashirwad Sewa Kendra Trust (ASK). The impact of these 7 water projects is estimated at 3,000 rural men, women and children. In addition to the water, financial assistance was also provided for Lydia's Hostel which is a girl's home for 20 girls who are from tribal areas and considered vulnerable to street life.
