THE DOWNTOWN EUGENE LOCATION HOUSED AN ADDITIONAL 4 CLASSROOMS FOR STUDENTS FOR WHOM A MORE TRANSITIONAL, COMMUNITY-BASED CURRICULUM HAS BEEN DESIGNED. THE SCHOOL PROGRAM IS STAFF-HEAVY AND INCURS THE HIGHEST AGENCY EXPENSES, PRIMARILY IN PAYROLL.

MOST INSURANCE COMPANIES ARE NOW ACCEPTED FOR ABA, SPEECH, AND SOME OF THE OCCUPATIONAL THERAPY OFFERED. EVEN A FEW SOCIAL GROUP PARTICIPANTS ARE ABLE TO BE BILLED UNDER INSURANCE.
