Pt I Line 2	The Hope Chest has a part time Missions of Hope Coordinator that reports to the BOD. He maintains income and expenses relating to the Missions of Hope Program. He requests funds from the community and mission trip partners to help fund the Mission of Hope activities. Once received, funds are wired to Central America, to be used to benefit the construction of a community medical clinic, a local orphanage and assist in ground logistics for volunteers for Missions of Hope. Funds are received by volunteers assisting in the program on the ground in Honduras. The Missions of Hope Coordinator records and tracks cash in and out, all construction expenditures and medical assistance disbursements. The medical clinic is being constructed by several sponsors. The Hope Chest assists in this construction process. To date The Hope Chest has funded approximately \$182,548.
