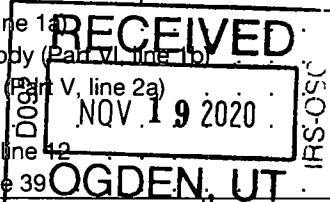

Scott Martin and his family worked in Israel an in the US in 2019. In Israel two bible studies were held weekly with an average of 20 in attendance and two weekly main services were held with an average of 45 people, one prayer meeting was held weekly with an average attendance of 15 and regular ongoing lifestyle outreaches were hold throughout the year and Shabbat fellowship meals were held on Friday nights. In the US 5 bible studies were held weekly around 50 ties and there were about 40 teaching and preaching ministry opportunities throughout the US and approximately 20 fellowship meals were held as an encouragement to believers through out the US.

Monte Martin ministered in the Birmingham area working with Be One Ministries (a ministry that reaches out to Jewish Christians) and attended 12 leadership meetings with around 8 people in attendance planning the work of their ministry to the Jewish Christians. He also conducted over 20 special events including special services for various Jewish Holidays, Conserts, First Friday Services and Community Shabbat Dinners with an average of 120 in attendance and a high attendance of 300 people at the 2019 Passover Service. He also taught at least 12 times in a Tuesday night Real Time Torah service with about 40 people in the bible studies and several hundred in attendance via live stream and also launched and led a prayer team with over 30 participants as well as led a prayer meeting with 5-15 in attendance weekly and organized and provided special care for members of the community who had special needs related to age and illness.

Missions Media ministry began in 2019. This ministry focused on creating and publishing podcasts which in 2019 specifically 70 podcasts were done with average weekly listeners of 175 people tuned in for a total listeners of 19,500 and these listeners were in 34 countries. These podcasts focused on a chapter by chapter recording of the bible in an explanatory format to teach listeners the context and meaning of what was written.

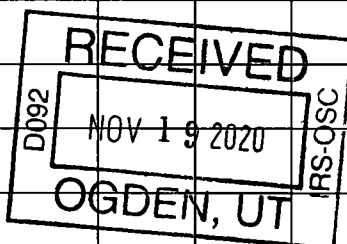



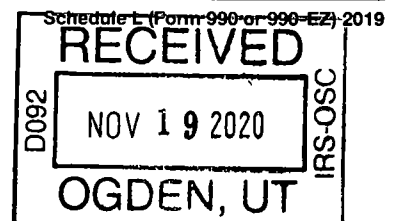
