Changing Life through Lenses (CLTL) empowers others to serve in their own communities by providing resources, best practices and other means of support to activate vision clinics for children in need across the United States.

4b (Code:) (Expenses \$ 1,234,868 including grants of \$) (Revenue \$ 125,530)

Kids Vision for Life (KVFL), EVF's cornerstone program, provides vision exams and glasses to children in need at no cost to the children or their families. Children climb on board a mobile vision clinic to receive a vision exam from an eye doctor and have the chance to pick out their own frames. The glasses are usually made on-site and are provided to the child before the end of the day. KVFL bridges the gap between the need and the solution, assisting an under-served population where it is most convenient in schools and at school-related or community-related events.

Awareness and Education - Raising awareness and educating parents is critical to solving the vision crisis for children in the United States. Most parents do not think about vision as a need for their child; it is an invisible problem that often goes unresolved. EVF works with schools to bring awareness to the importance of good vision through educational programs for student, parents, and teachers.

For the years ended December 31, 2019 and 2018, the Foundation had no net unrelated business income. Accordingly, no provision for income tax has been provided. GAAP requires the evaluation of tax positions taken or expected to be taken in the course of preparing the Foundation's tax return to determine whether the tax positions are more likely than not of being sustained by the applicable tax authority. Tax positions not deemed to meet the more likely than not threshold would be recorded as a tax benefit or expense in the current year. A reconciliation is not provided herein, as the beginning and ending amounts of unrecognized benefits are zero, with no interim additions, reductions or settlements. The Foundation is relying on its tax-exempt status and its adherence to all applicable laws and regulations to preserve that status. However, the conclusions regarding accounting for uncertainty in income taxes will be subject to review and may be adjusted at a later date based on factors including, but not limited to, ongoing analysis of tax laws, regulations and interpretations thereof. The Foundation recognizes interest and penalties, if any, related to uncertain tax positions as income tax expenses. The Foundations's information returns filed are generally subject to examination for three years after the later of the due date or date of filing.
