AHA FOUNDATION WAS FEATURED IN MULTIPLE NEWS OUTLETS INCLUDING NBC NEWS AND CBS BOSTON DISCUSSING A REPORT BY SENATE HSGAC ON A FEDERAL MARRIAGE LAW LOOPHOLE IDENTIFIED BY AHA. AHA FOUNDATION'S TWEETS RESPONDING TO THIS NEWS REACHED OVER 57,000 SUPPORTERS. IN 2019, AHA FOUNDATION PARTICIPATED IN FOUR PODCASTS INCLUDING THE IN-SIGHT JOURNAL, WOMENANCE TO SOCIETY, AND NIGHTSIDE WITH DAN REA IN THESE PODCASTS, SENIOR DIRECTOR AMANDA PARKER RAISED AWARENESS ABOUT THE PREVALENCE OF CHILD MARRIAGE AND FGM IN THE U.S. AND CALLED FOR GRASSROOTS SUPPORT IN EVERY STATE TO END THESE HUMAN RIGHTS ABUSES. PUBLISHED IN THE WALL STREET JOURNAL, AYAAN ADRESSED THE PROBLEM OF ISLAMIST ANTI-SEMITISM. SHE SPECIFICALLY ADDRESSED THE COMMONALITY AND SHARED EXPERIENCES BETWEEN HER LIFE AND REP. ILHAN OMAR, WHO BOTH GREW UP IN SOMALIA. AYAAN TOUCHES ON THE DIFFICULTY OF UNLEARNING HATE WITHOUT COMING TO TERMS WITH HOW YOU LEARNED TO HATE. AHA FOUNDATION CO-WROTE AN OP-ED PUBLISHED IN THE LOUISVILLE COURIER-JOURNAL, PART OF THE USA TODAY NETWORK, WITH FGM SURVIVOR JENNY AND BILL SPONSOR KENTUCKY STATE SENATOR JULIE RAQUE ADAMS. THIS PIECE RAISED AWARENESS OF THE PRACTICE WITHIN THE U.S., AND KENTUCKY MORE SPECIFICALLY. IN RECOGNITION OF THE INTERNATIONAL DAY OF ZERO TOLERANCE FOR FEMALE GENITAL MUTILATION AMANDA PARKER, SENIOR DIRECTOR AT AHA FOUNDATION, WAS INTERVIEWED FOR GOOD MORNING CLEVELAND, ABC NEWS 5. SHE ADVOCATED FOR CITIZENS TO STAND UP AND DENOUNCE THIS PRACTICE, AND COMMIT TO PROTECTING WOMEN AND GIRLS FROM THIS HUMAN RIGHTS ABUSE. AMANDA PARKER WAS FEATURED ON WYOMING PUBLIC RADIO, A NPR AFFILIATE TO DISCUSS THE UPTICK IN FGM CRIMINALIZATION IN STATES ACROSS THE U.S. AND THE LACK OF PROTECTIVE LAWS AMONG WESTERN STATES. INTERVIEWED BY KUTV, A CBS NEWS AFFILIATE, AMANDA PARKER SPOKE ABOUT OUR EFFORTS TO BAN FGM IN UTAH. MS. PARKER AND THE BILL SPONSOR, FORMER REP. KEN IVORY SPOKE ABOUT THE IMPORTANCE OF BANNING THIS PRACTICE, INCLUDING EMPOWERING SURVIVORS TO PURSUE CIVIL SUITS IN ADDITION TO CRIMINAL CHARGES. MS. PARKER WAS INTERVIEWED IN A PODCAST FOR IN-SIGHT JOURNAL DISCUSSING THE MENTAL AND PHYSICAL HEALTH CONSEQUENCES OF FGM, THE PREVALENCE OF THE PRACTICE ACROSS THE GLOBE, AND HOW CERTAIN CULTURAL NORMS CAN PERPETUATE THE PRACTICE. APPEARED TWICE ON WOMENANCE TO SOCIETY PODCAST TO SPEAK ABOUT FGM AND CHILD MARRIAGE, AMANDA PARKER ALERTED THE PUBLIC TO THE DANGERS AND REALITY OF BOTH OF THESE HUMAN RIGHTS ABUSES. TRAININGS AND CONVENINGS: SINCE INCEPTION, AHA FOUNDATION HAS TRAINED MORE THAN 3,000 PROFESSIONALS LIKELY TO ENCOUNTER SURVIVORS OR AT-RISK INDIVIDUALS FACING HONOR VIOLENCE, FORCED MARRIAGE, CHILD MARRIAGE, OR FGM. IN 2019, TRAINED MORE THAN 200 PROFESSIONALS LIKELY TO ENCOUNTER SURVIVORS OF FGM, HONOR VIOLENCE, FORCED MARRIAGE, OR CHILD MARRIAGE IN BOISE, IDAHO. PROFESSIONALS ATTENDED TRAININGS AT THE FACES OF HOPE VICTIM CENTER, THE CENTRAL DISTRICT HEALTH DEPARTMENT, AND THE FAMILY MEDICINE RESIDENCY OF IDAHO.
