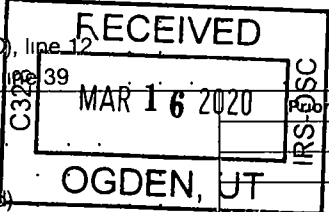

Resources include informational and cultural materials, computers, and internet access, programs, classes and displays. Staff develop collections and programs to meet user needs and requests and assist users in locating and utilizing information.

These range from babytime and toddler storytimes to programs on understanding and choosing Medicare supplements. Other costs include advertising, overhead, and maintenance costs and office supplies related to or used in the program.
