Brown University presented the morning keynote titled "Quality Long-Term Care: How Research and Innovation Lead to Better

Outcomes (or Not)." Eighteen breakout sessions were held including three sessions on each of the following six topics: Ethics and

Diversity, Aging in Place, Careers Policy Research, Mental Health, Personal Perspectives and Rural Community Solutions.

The conference was attended by 455.

The annual Gerontologist of the Year award was presented, along with six scholarships awarded to higher education students

majoring in a gerontology related field in Minnesota. This conference allows practitioners, researchers, faculty and students to gain

information on evidenced-based services to seniors, to learn about relevant research that improve results, and to highlight new

new services that meet emerging and critical issues, such as elder abuse. Attendees receive continuing education credits for

their participation in the conference
