**MEET ME AT THE GATE®** Since 1997, KHNM has worked with churches, organizations, and individuals in ministering to Christian neighbors coming out of prison for whom no family-home-based program is available. Since 2008, it has worked through its affiliate organization, Koinonia House® of Wheaton (KHW), to provide Christian men coming from prison a residential family-home-based discipleship program. In 2019, KHW assisted ten individuals with re-entry issues and three men resided at the KHW.

Average weekly attendance at Radical Time Out™ (RTO) in 2019 was 77. RTO is an evening of dinner, fellowship, prayer and worship, where everyone is welcome to experience the love and grace of Jesus Christ, regardless of color, class, culture, crisis, or crime.

**IN-PRISON MINISTRIES.** In 2019, KHNM conducted multi-day Prayer Conferences in seven adult correctional centers for over 500 men in the Illinois Department of Corrections. These events focus on presenting the Gospel of Jesus Christ and demonstrating how to grow their relationship with God the Father through prayer in order that they will become mature believers, able to transition well on their return to society. Christian literature and Bibles are distributed when allowed. KHNM also conducted 12 monthly services at Sheridan Correctional Center, 14 special services at Dixon Correctional Center, a Christmas service at East Moline Correctional Ctr. and participated in Re-entry Summits at East Moline, Illinois River, and Sheridan Correctional Centers.

Outside of Illinois, KHNM ministered at the Louisiana State Penitentiary at Angola, Elyan Hunt Correctional Ctr. (LA), the Louisiana State Police Barracks, and the U.S. Penitentiary at Terre Haute, IN. A 2019 highlight was ministering in four prisons for men and one for women in the country of Ecuador.

Correspondence is another in-prison ministry vehicle. In 2018, KHNM responded to 114 inmate letters and the RTO family held a "card shower" for approximately 50 inmates directly connected to those attending RTO. **BUILDING BRIDGES, RESTORING HOPE** Expenses cover activities such as helping families of incarcerated individuals, educating the public on the needs of people returning to society from prison, and ministering to donor families. In 2019, KHNM staff assisted 43 individuals/families through formal and informal advisory sessions. KHNM staff also spoke/taught at 24 services in 12 churches, 1 school, and 8 parachurch ministries and participated in 5 radio programs in IL and FL.

As we grow in understanding God's radical love for us, we will then grow in radical love for others, including those who are incarcerated, in crisis, and/or the family members thereof. Between 5-15 fathers gather each Wednesday at the Koinonia House® of Wheaton to pray for their children. Our board of trustees holds a monthly prayer conference call. Highlights for 2019 include introducing Oración Radical (the Spanish edition of KHNM's book Radical Prayer) to churches and pastors in three major cities of Ecuador.
