Their tagline "art, create, motivate, impact" summarizes WHAM's objectives to connect people through the arts; to support, advance and promote artistic awareness, participation, expression in all areas of Visual Arts and other disciplines; and to bring the arts to people of all race, abilities and economic status in the West Valley cities and towns.

Education: Education is an important aspect of the organizations mission; offering all levels of classes to children, teens and adults. Classes include painting, drawing, clay sculpture, mixed media, new media, gourd carving and more. Instructors have years of training and experience. Classes also include an Adaptive Art program for children and adults with special needs. "Art: A Path to Healing" is a free twelve-month art program for veterans and first responders coping with stress. Through this program, veterans enjoy a comfortable, safe environment to learn and create art in which to collaborate and connect with others who share their experience. Professional art instructors guide the learning experience. There is also a teen program which encourages youths to participate in classes, events and projects.

4b (Code: N/A) (Expenses \$ 33,443 including grants of \$ 0) (Revenue \$ 52,273)

Public Exhibits: WHAM houses the WHAM West Gallery which, each month, hosts a different art exhibit and reception to introduce new art created by its members and other local, regional and national artists. Providing this gallery that offers free admission to the public, is a part of WHAM's overall mission to enhance the quality of life for the residents of the area, while at the same time, offering a venue for new artists to share their talent. In addition, the public has the opportunity to see artists at work and art being created, by strolling through the facility where artists are able to rent studios at a minimal cost.

Contract Services: At the request of surrounding municipalities and businesses, WHAM provides specific services as requested, which may include classes, outdoor murals, and art pieces specifically designed for the customer. A large part of these services is provided by WHAM on Wheels (WOW). WOW is designed to provide artistic activities and encompass art into various events. WOW accommodates projects for 50-300 individuals at the requestor's site by way of a fully-supplied art trailer.
