Expenses include subsidies and direct financial assistance in the amount of \$225,665. This makes participation possible for 36% of the young people we engage, 136 Teen Reach participants, 90 Program participants, and 52 School Age participants. The remaining expenses include wages, benefits, program supplies and field trip expenses. United Way, Illinois Dept of Human Services, Child Care Connection, Peoria County Health Dept, and Community Foundation of Central Illinois, provided grants that provided assistance with the above mentioned expenses. The program revenue was generated through program fees for select programs such as Youth Services, Youth Sports, Before/Aftercare, and Day Camp.

Social Responsibility Our YMCA believes in giving back and supporting the community we live in. We have been listening and responding to our community's most critical needs for more than 120 years. Programs such as, a free basketball league and mentoring program to at risk youth (East Bluff Rebound League), Military Outreach Initiatives, as well as, our YUSA Safety Around Water Initiative. Expenses for these programs included \$15,013 for East Bluff Rebound, \$10,325 for military, and \$3,000 for swim. In 2019, we engaged over 155 participants in our Rebound league, had 25 members participate in our military initiative, and 90 children participate in our Safety Around Water Initiative.
