WE RECEIVED DONATIONS TO HELP THOSE AFFECTED AND THE FUNDS WERE USED TO REPLACE 4 MOBILE HOMES AND TO REPAIR HOUSES THAT WERE DAMAGED. HELP WAS ALSO GIVEN TO 4 CHURCHES WHICH WERE DAMAGED. REPAIR WORK HAS NOT BEEN COMPLETED ON HOUSES BY THE END OF THE YEAR.
