This is accomplished by using various methods of reaching villages and people for Jesus Christ; medical camps, disaster relief, etc. Then the organization installs a new water well and plants a church. With an installed pastor, the Organization can then strengthen the village by providing food, clothing, medical training, educational supplies, literature, tapes, and Bibles. After this has been accomplished, the Organization then provides a vocational training center to help the village become self-sustaining.
