ENVIRONMENTAL HEALTH PROGRAM We worked diligently to force Maine agencies to address the growing crisis of contamination of our food and water with PFAS, toxic "forever chemicals," that do not break down in the environment or in our bodies After making the tragic story of a Maine dairy farm ruined by PFAS contamination from the industrial and municipal sludges the state had permitted for application as a fertilizer national news, we fought for more testing and policy changes to identify other contaminated sites, support remediation, and avoid additional contamination We won legislation to ban the use of PFAS as well as hormone disrupting phthalates from food packaging, proudly making Maine home to one of the strongest laws in the country for eliminating toxics from our food Our national campaign to hold food manufacturers and retailers accountable delivered over 100,000 signatures to Kraft Heinz calling on them to follow the lead of other food giants in eliminating phthalates from their supply chain The annual Retailer Report card, scoring the chemical safety policies of top merchants, was coauthored by us and continued to deliver results in encouraging more health-protective policies as average scores continue to increase We also continued to monitor the US EPA's implementation of the 2016 chemical policy reforms, documenting agency failures and participating in public interest lawsuits to demand adherence to the law

SUSTAINABLE ECONOMY PROGRAM In 2019, we continued to promote the manufacture of safer chemicals from renewable, sustainable, biobased material, to replace toxic chemicals derived from climate-destroying petroleum. We developed and documented the need for a renewable chemicals tax credit in Maine that would help increase our state's competitiveness and help make us a leader in this new and growing sector. We continued to actively promote Maine's resources to leading biobased technology companies at conferences and in one on one meetings, as well as documenting the opportunities to put Maine's underutilized forest resources to work creating sustainable, low-carbon biobased chemicals and other products.
