Volunteer Center United Way of Portage County's Volunteer Center matched 1,516 people to volunteer opportunities in 2018, providing more than \$50,000 worth of volunteer service. Through its VolunteersRock.org website, the Volunteer Center connected people to hundreds of local volunteer opportunities, including those with Project Fresh Start and Make a Difference Day. Research shows that when more people volunteer, the benefits and impact on the community are measureable. In 2018, the Volunteer Center continues to offer Strategic Volunteer Opportunities at area employer businesses.
