In addition, the Center qualifies for the charitable contribution deduction under Section 170(b)(1)(A) and has been classified as an organization other than a private foundation under Section 509(a)(2). The Center follows guidance that clarifies the accounting for uncertainty in tax positions taken or expected to be taken in a tax return, including issues relating to financial statement recognition and measurement. This guidance provides that the tax effects from an uncertain tax position can only be recognized in the financial statements if the position is more likely than not to be sustained if the position were to be challenged by a taxing authority. The assessment of the tax position is based solely on the technical merits of the position, without regard to the likelihood that the tax position may be challenged. The Center files information returns in the U.S. federal and state of Wisconsin jurisdictions. Tax years open under the federal statute of limitations include 2016 through 2019. Tax years open under the state of Wisconsin include 2015 through 2019. Management has determined that there is no unrelated business income to report and the Center has not historically filed any unrelated business income tax returns. Tax years remain open for years in which an income tax return has not been filed. The Center recognizes, if necessary, interest and penalties related to unrecognized tax benefits in the provision for income taxes. There were no interest or penalties related to income taxes that have been accrued or recognized as of and for the years ended December 31, 2019 and 2018.
