ANOTHER OUTTING IS THE WOMENS' EVENT WHERE ONLY WOMEN ARE ALLOWED TO REEL IN FISH. THE OTHER FOUR OUTTINGS ARE GENERAL EVENTS WHERE ANYONE CAN REEL IN A FISH. AT THE START OF THE EVENT, A MARINE RADIO CHANNEL IS DESIGNATED FOR EVENT TALK. SINCE THESE ARE FRIENDLY, LESS COMPETITIVE EVENTS, HELP WITH ANY FISHING TOPIC IS ALWAYS AVAILABLE ON THE DESIGNATED RADIO CHANNEL. THE TOP BOAT IN THE CLUB OUTINGS IS REQUIRED TO SPEAK AT ONE OF THE CLUB MEETINGS TO TEACH THE MEETING ATTENDEES THEIR TACTICS AND TECHNIQUES THAT MADE THEM SUCCESSFUL.
