We provide a NEW FAMILY PACK to recently diagnosed families with information and it includes misc things for a hospital stay.

Direct financial assistance to pay a small bill (water, Utility, phone) or rent. This is capped at \$500.

We gave a memorial to a family with a mother and child with cancer. The mother passed away.
