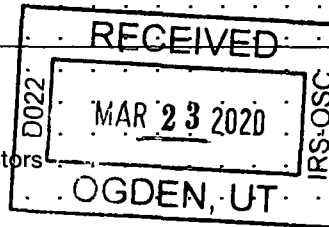

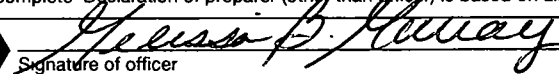

All of these grants fulfilled the Library's stated purposes and commitment to the Pewaukee community.
