Married couples called Family Teachers are responsible for structured supervision of youth in daily living and structured activities. Services are delivered to families in their own homes by trained Boys Town Family Consultants who help parents build on their strengths and enhance or learn new parenting skills. Boys Town Washington D.C. Inc.s target population is children who have been released from a Juvenile Justice facility and are returning home. Boys Town Washington D.C. Inc.s Family Consultants work one-on-one in the home with the youth and their parent or caregiver to assist the youth in developing appropriate coping and behavior skills and social skills in order to reduce recidivism. Family Consultants are trained to work for 10-12 weeks with each family to teach methods and systems that will keep their families together and address current and potential roadblocks to the familys success. Boys Town Washington D.C., Inc. is collaborating with the Office of Victim Services and Justice Grants for children experiencing truancy problems attending D.C. public schools.
