The Foundation increased awareness of childcare issues by hosting the statewide Child Care Summit in Des Moines with 125 attendees and distributed multiple media releases focused on the childcare crisis and other women's issues. The programs not only address affordable access to care beyond school hours but effectively improve students' reading, STEM, and social emotional skills Curriculum, like Conscious Discipline, engage families and community in developing skills to promote social emotional learning. This is the third consecutive year of IWF funding.
