Special Assistance Fund provides financial assistance for assistive technology needs such as wheelchairs, communication devices, hearing aids, orthotics, etc., for which no other funds are available. 3. Playful Potential Program is a durable equipment lending program, which allows families to borrow expensive, yet necessary, equipment that helps their child reach their fullest potential. 4. Funeral Assistance Program helps to offset funeral expenses in the tragic event that a child dies.
