For those not making any payments within 120 days after the date of the invoice, a series of collection letters begin to be mailed out to them. FCHC usually waits until the patient has received 3 statements before beginning to send out reminder letters that their account is past due and that we have a financial assistance policy. If after 5 letters, which would be 240 days, and the patient has not returned the completed application for assistance, the account is turned over to the collection bureau. If a patient applies for financial assistance within 240 days of the date of the first invoice the patient charges are pulled from collections as the Hospital works with the patient to complete the application. If the application is completed, the account is written off in part or completely depending on how much assistance they qualify for. There are no collection efforts made on patient accounts that qualify for the charity care program.

The main county, in which the Health Center is located, is a federally-designated primary care HPSA due to low income. FCHC is located in Park River, which is a federally-designated medically underserved area. The unemployment rate of the service area is 6.1%. Nearly 21.0% of the area population is over 65 years of age and just over 22.7% of the area population are children zero to seventeen years of age.

FCHC participates in mentoring medical, pharmacy, nursing, and health careers students. First Care Health Center also provides nail care at a nominal fee by licensed staff. This service serves as a first step in checking for issues in diabetic patients. The fee does not cover the cost of space, salaries, or supplies but is done more as a service to patients. First Care Health Center provides many other services that benefit the community for which there is little or no reimbursement. The following list provides examples of some of the services and programs offered: *Tours of the hospital to children. *Provide rooms for overnight stay for families of patients. *Training to area vocational high school students. *Provide preceptorships for nurses training. *Provide educational pamphlets and brochures to the community. *Provide free medical advice from registered nurses via telephone. *Provide meals to parents of pediatric patients. *Personnel run errands for patients. *Provide supplies and movies for activities and crafts for swing-bed patients. *Pay for local travel for swing-bed patients.

Although FCHC believes these are very important issues, there are some things we don't have a lot of control over.
