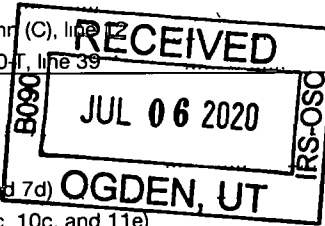

THE RESCUED ANIMALS WERE SLATED FOR EUTHANIZATION BY THE LOCAL ANIMAL SHELTERS. SOME REQUIRED MEDICAL ATTENTION BEFORE TRANSPORTING AND ALL REQUIRED A HEALTH CHECK PERFORMED BY A VETERINARIAN BEFORE BEING TRANSPORTED.
