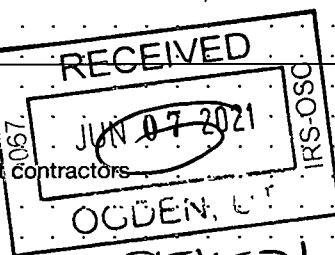

The organization's activities accomplished this by educating members of the public, including members of legislative bodies, about public safety issues, including publication of such information on its website.

Reasonable cause statement for late filing

Safe Silver Spring, Inc., requests an abatement of any penalties for late filing under section 6652 of the Internal Revenue Code for reasonable cause. The organization's then Secretary-Treasurer, James W. Brosnan, had malignant brain cancer (gliosarcoma). Because of diminished mental capacity, he failed to file the return or to request an extension of time to file.

As secretary-treasurer, he was responsible for maintaining the organization's books and records, which he failed to do. Lack of books and records has required his successors in office to conduct an exhaustive search of his files. Not finding records, the information needed to file the return had to be reconstructed from bank records.

Although the organization's other board members were aware that Mr. Brosnan had a malignant brain tumor, they did not realize that its effects included an inability or unwillingness to be responsible for the financial affairs of Safe Silver Spring. He continued to report to the board that required state and federal filings complied with legal and tax requirements. Now recognizing the dangers of resting sole responsibility for tax and other filing requirements in the hands, the board has adopted a policy of regularly reviewing the status of required filings, which it believes will prevent the situation from recurring in the future.

Under penalties of perjury, I declare that I have examined this request, and to the best of my knowledge and belief, the facts presented in support of the request for abatement of penalties are true, correct, and complete.
