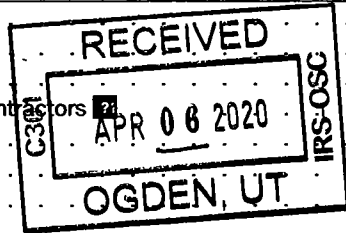

**PART III - Line 28 - STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS**

This organization has engaged in activities necessary for the construction and production of a non-profit, non-commercial Christian radio station. The broadcast initially reached a target audience of 300,000 listeners in 16 counties of northeast Kentucky. In May 2016 the station began to stream via the internet to a world-wide audience. The daily programming consists of 22 hours of classic Christian music and two hours of family interest/community news that encourages family values and a proper relationship with God. Management and operation of the radio station are performed by dedicated volunteers, and promotion and fundraising are achieved through personal contact, newsletters, email, webpage, social media, and other means of public awareness.
