Open Source Software Developmet (Dev): Mifos X is free & open source financial software developed to build the complete range of financial services required for effective financial inclusion. The reference apps are examples of how to build microcredit, microsaving and digital financial service applications such as mobile wallets using Mifos X. In 2019, a major focus of development was stabilizing our core platform & release management and extending it to integrate with other foundational open source (OS) digital public goods. With a grant from DIAL, we began to build another OS tool, the payment hub to integrate Mifos with Mojaloop, an OS interoperable payments platform for financial inclusion to provide an end to end referonco implomentation and lab environment for digital financial services. With this grant, we also focused on building a standard customer API layer on our next generation architecture to enable more secure development and deployment of our self-service applications which we continued to evolve and extend. We also secured a grant from the Gates Foundation to further develop payment hub to be a more flexible and extensible open source tool for for integrating with payments and enabling financial inclusion providers to effectively participate in real-time payments. With these tools in place we now have a broader set digital public goods - reference tools & applications to demonstrate how to deliver financial services to the poor via open source accounts/wallets, interoperable payment rails, and self-service APIs.

Community (Comm): Our global community is made up of financial institutions, local technology partners, and volunteers who use, support & develop the software respectively. We provide the tools, framework, governance, and infrastructure for global collaboration and conduct outreach and advocacy to reach new users, recruit new partners, cultivate now solutions and attract new volunteers. We started 2019 with 350 Mifos installations roaching a total poor cliont base of 10M clients & grew this to more than 14M clients by the end of 2019. We grew awareness & participation by adopting a broader message of democratizing financial services and extending the breadth of our reference tools & APIs to include payments integration & self-service channels via standardized APIs. We received a number of awards including Runner-Up for Best Financial Inclusion Initiative at 2019 London Financial Innovation Awards & Finalist for Fintech for Good Award. We maintained our partner program of 125+ local deployment partners & 30 innovators building solutions to lift people out of poverty. This year as part of our sustainability efforts, we continued to take on more technical assistance projects, assisting with knowledge transfer & custom development for new solutions on Mifos X. We continued to utilize volunteers effectively across all disciplines including product managomont, strategy, and more. External contributions from university & intern programs were impacdtful again with 17 interns participating in Google Summer of Codo and dozons of high schoolers participating in Code-In.

Education (Edu): In 2019, with a broader positioning around democratizing financial services on top of a more comprehensive end to end set of reference open source building blocks for account managomont, core banking, interoperable payments & self-service applications, we continued to speak at conferences and do more advocacy at a global level to newer audiences. At open source conferences including OSCON in Portland, Linuxfest Northwest and ApacheCon, we continued to build awareness but now began emphasizing the value of upstream development of members of the community to create a virtuous cycle of contributions. We also spoke at the Africa Fintech Summit, a credit union hackathon in Canada, & spoke at 4 Mojaloop Convenings in Tanzania, Ivory Coast, and South Africa to integrate and align our referonco tools with the Mojaloop open source payments community. We also introduced a new regular Mifos online webinar series including guests talking about digital identity and regulatory compliance. We maintained our online collaboration infrastructure of documentation, forums, chatrooms, wikis, tutorials, and mailing lists. We continued our training and technical assistance services helping our partner community design and build responsible and appropriate solutions for digital financial services on our open source platforms. 2019 was highly successful in advocating and educating the adoption and contribution to digital public goods for financial inclusion.
