The discarded equipment and supplies are quite adequate for the hospitals in Ghana. Since medical facilities make these replacements on a rotating basis, the number of donors with available items in a single year is small, but the number and value of items from each donor is large. This creates a large concentration of non-cash donations annually from a small group of donors. None of these donors are involved in the management of the organization, nor are they the same donors every year. The remaining donations of cash for operating expenses are spread over numerous smaller donors.
