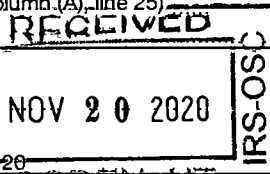

THE TRADE SHOWS ARE OPEN TO ALL PARTICIPANTS IN THE INDUSTRY AND TO THE GENERAL PUBLIC. THE RUG SHOW INC ORGANIZES THESE TRADE SHOWS BY RENTING A GRAND LOCATION/HALL AND BREAKS DOWN THE AREA INTO BOOTHS/STALLS. DEPENDING ON THE SIZE OF THE BOOTH, RUG RETAILERS AND/OR WHOLESALERS PAYS A BOOTH RENTAL RATE PER SQUARE FEET FOR THE SUBDIVIDED SPACE TO SHOWCASE THEIR PRODUCTS.
