Obj. 1: By September 2022, the Pine Ridge Area Chamber of Commerce will create and operate a venue, the Lakota Living Village, that will attract no less than 50,000 visitors in the third year of operation, generating at least on half million dollars in the third year, that will be reinvested into the tourism industry on the Pine Ridge Reservation. (Note: this is in Jackson County)

PRACC began implementation of this project in October 2019. The first quarter was spent setting up the project, hiring staff, and intimal material orders.

Obj. 2: By September 2022, the Pine Ridge Area Chamber of Commerce will develop and implement a sustainable marketing plan for tourism on the reservation that will a) increase tourism traffic in Oglala Lakota county (land entirely on the reservation) by 8% as measured by attendance numbers at the end of the 3rd year of the project at seven specific tourist destinations; and b) increase visitor spending by 5%, jobs at the end of 2022, over 2018 data as documented by SD Dept of Tourism data for that county.

In the 1st qtr of the project, PRACC began informing the South Dakota Tourism industry about the new attraction. PRACC started the marketing plan and prepared a formal introduction to the SD Tourism conference. Created marketing material and plans to deliver it.

4b (Code:) (Expenses \$ 38315 including grants of \$) (Revenue \$ 30000)

This grant is an operation grant. PRACC utilizes funds from this grant to pay two partial salaries. the grant is designed to assist organization with the adaptation of art in programing. PRACC utilized these funds to assist in the planning for the ANA SEDS grant. The funding also provided time to plan fundraising for an outdoor artist venue.

4c (Code:) (Expenses \$ 31002 including grants of \$) (Revenue \$ 23000)

Obj 1: By August 31, seven artists will have completed residency at PRACC. PRACC had seven artists complete an artist in residence at the Pine Ridge Visitor Center located at 7900 Lakota Prairie Dr. Kyle, SD

Obj 2: By August 31, seven emerging artists will accompany master artists in residence. PRACC hosted seven emerging artists at the Pine Ridge Visitor Center. Master artistes provided mentor-ships for the emerging artists.

Obj 3: PRACC will host an art camp for youth with master artist instruction. PRACC hosted the youth art camp and the Pine Ridge Visitor Center.

Obj 4: By October 31, all artist income and exit surveys will be completed, analyzed, and ready to report to First Nations Development Institute. By October 31, 13 of the 14 artists completed income and exit surveys.
