Job creation activities with African entrepreneurs - AEC provides a range of capacity-building supports, training, advising, and digital tools to help African entrepreneurs - including youth, women, refugees, and people living with disabilities - to grow their businesses to create jobs. We worked with more than 6,000 entrepreneurs in 2019 to create almost 6,000 jobs.

Loan funding to entrepreneurs - AEC provides financing at below-market rates to African entrepreneurs, so that these funds can be used to grow their businesses to create jobs. With backing from Kiva, these loans are made with the support of crowd-funding investors, and is a line of credit for AEC. These loans are within our charitable scope as most marginalized entrepreneurs are not able to access the financing required to meet their goals from traditional means (like banks).
