AS OF 2019, OVER 1.65 MILLION SEA TURTLES FROM FOUR SPECIES HAVE HATCHED ON CAREYES BEACHES AND BEEN RELEASED SAFELY INTO THE PACIFIC OCEAN. A TEAM OF FOUR EXPERIENCED STAFF PATROLLED THE CAREYES BEACHES YEAR-ROUND TO PROTECT TURTLES AND THEIR NESTS FROM PREDATORS. IN 2019, 1,379 TURTLES NESTED AND 114,085 TURTLES WERE RELEASED. AN ADDITIONAL TEAM MEMBER FOR PLAYA TAPEIXTE WAS HIRED FOR FOUR MONTHS DIRECTLY BY THE FOUNDATION TO CAMP AND GUARD THE BEACH IN RESPONSE TO AN INCREASE IN THE NUMBER OF HAWKSBILL TURTLES NESTING THERE. THROUGH AN ECOLOGY EDUCATION PROGRAM, THE FOUNDATION BROUGHT LOCAL CHILDREN AND FAMILIES TO THE TURTLE SANCTUARY TO LEARN ABOUT AND PARTICIPATE IN THE CONSERVATION EFFORT. ADDITIONAL EVENTS INVITED THESE SAME COMMUNITY MEMBERS TO A NEARBY BIOLOGICAL RESEARCH STATION TO DISCOVER THE REGION'S DIVERSE FLORA AND FAUNA. THE FOUNDATION ORGANIZED 23 ECOLOGY EDUCATION EVENTS IN 2019. IN ADDITION TO THE EXPENSES BEING REPORTED IN PART IX OF THIS RETURN, THERE WERE IN-KIND GIFTS OF \$32,393.

IN OCTOBER 2015, HURRICANE PATRICIA DEVASTATED THE TEN VILLAGES SERVED BY THE CAREYES FOUNDATION WITH THAT IN MIND, THE FOUNDATION ESTABLISHED THE HURRICANE PATRICIA FUND WITH THE PURPOSE OF 1) BUILDING AN EMERGENCY SHELTER AT A PRIMARY SCHOOL SITE IN EACH VILLAGE, AND 2) FULLY EQUIPPING EACH OF THESE SHELTERS WITH ALL SUPPLIES NECESSARY IN THE EVENT OF A FUTURE NATURAL DISASTER. THE CAREYES FOUNDATION WORKED VERY CLOSELY WITH THE MEXICAN GOVERNMENT. ONCE THE GOVERNMENT AGENCIES COMPLETED THEIR REPAIRS TO EACH PRIMARY SCHOOL, THE FOUNDATION INSTALLED STORMPROOF DOOR KITS (REINFORCED STEEL DOORS AND FRAMES) ON THE CLASSROOMS INDICATED FOR SHELTER USE AND HURRICANE PANELS (REMOVABLE STEEL SHIELDS) TO BE PLACED OVER THE WINDOWS OF THESE CLASSROOMS DURING A STORM, AS WELL AS ENSURING THAT EACH SCHOOL HAS A FUNCTIONING WATER TANK OF SUFFICIENT SIZE TO SUPPLY AMPLE FILTERED DRINKING WATER. THE FOUNDATION SUCCESSFULLY COMPLETED CONSTRUCTION ON THE EMERGENCY SHELTERS UNDER-BUDGET IN APRIL 2018. EACH EMERGENCY SHELTER IS FULLY EQUIPPED WITH ALL SUPPLIES NECESSARY IN THE EVENT OF A NATURAL DISASTER, INCLUDING COLLAPSIBLE COTS FOR SLEEPING, AN ELECTRICAL GENERATOR, A FIRST AID KIT WITH EMERGENCY MEDICAL SUPPLIES, AND AN EMERGENCY KIT. THE EMERGENCY KIT CONTAINS AN AXE, PICKAXE, AND MACHETE, AS WELL AS ADDITIONAL WATER FILTERS AND BATTERY-POWERED LANTERNS WITH RECHARGEABLE BATTERIES AND BATTERY CHARGERS. IN 2017, THE CAREYES FOUNDATION INITIATED A NEW PARTNERSHIP WITH THE HAPPY HEARTS FUND (HHF) IN ORDER TO REBUILD THE 12 LOCAL PRESCHOOLS THAT WERE SEVERELY DAMAGED DURING HURRICANE PATRICIA. IN 2018, WE COMPLETED THE RECONSTRUCTION AND IMPROVEMENT OF ONE LOCAL PRESCHOOL, A PROJECT WHICH WAS ALMOST ENTIRELY FUNDED BY HHF. IN SEPTEMBER 2019, THE CAREYES FOUNDATION USED RESERVE FUNDS FROM THE HURRICANE PATRICIA FUND TO PROVIDE BASIC ESSENTIALS AND CLEANUP SUPPLIES TO THE COMMUNITY OF CHAMELA, WHICH WAS AFFECTED BY SEVERE FLOODING AS A RESULT OF HURRICANE LORENA. WE ALSO ORGANIZED DONATIONS OF CLOTHING, LINENS, HOT MEALS, AND OTHER SUPPLIES FROM CAREYES COMMUNITY MEMBERS.

THE FIRST WORKSHOP IN 2015 ATTRACTED A GREAT DEAL OF PUBLIC INTEREST AND LED TO A PARTNERSHIP WITH CINEPOLIS, WHO DONATED PROJECTORS AND A SOUND SYSTEM TO EQUIP A MOVIE THEATER IN CAREYES THAT OPENED IN APRIL 2016. USING THIS THEATER, THE CAREYES FOUNDATION'S CINEMA & COMMUNITY PROGRAM NOW HOSTS REGULAR EVENTS FOR LOCAL SCHOOL CHILDREN TO EXPOSE THEM TO THE CINEMATIC ARTS BY OFFERING EDUCATIONAL SCREENINGS ON A VARIETY OF SUBJECTS, PAIRING FILMS WITH GUEST SPEAKERS WHO GIVE A PRESENTATION ON A RELATED THEME. IN 2019, WE ORGANIZED 17 OF THESE SCREENINGS, WITH AN AVERAGE OF 26 CHILDREN ATTENDING EACH EVENT. IN ADDITION TO THE EXPENSES BEING REPORTED IN PART IX OF THIS RETURN, THERE WERE IN-KIND GIFTS OF \$25,182.
