Victim advocates help survivors navigate legal and bureaucratic situations to help them apply for government and privately funded assistance and help them re-assimilate into society.*

Awareness and Prevention Training for At-Risk Youth: Fierce Freedom provides classroom and school assembly programs in public and private schools to teach middle and high school students about what human trafficking looks like in their hometowns. Fierce Freedom has developed a specialized version of this curriculum which is used in area Juvenile Detention Centers, where the population is at an elevated risk of being victimized by traffickers.
