All loans have to be repaid before any further loans will be made. A three day seminar was given to any one 13 years old or older on the topic of Transforming The Mind. This seminar was put on by teams from the United States. In Sakota 15 widows were given small business loans after attending training in small business principles and book keeping. As a result of the water wells that Life Center drilled in Sekota water distribution points have been established to bring safe drinking water to the Sekota district. Seven widows in Sekota were taught how to make liquid soap and have started selling the soap to provide income for themselves and their families.
