FOLLOWING OUTSTANDING SPEAKER’S PRESENTATIONS, WE HELD A SESSION FOR THE PUBLIC FOLLOWED BY A DINNER THAT ALLOWED THE PUBLIC TO INTERACT WITH THE SCIENTIFIC COMMUNITY. THE SPEAKERS FROM MANY US UNIVERSITIES AND INSTITUTES WERE INTERNATIONAL IN SCOPE AND PRESENTING INFORMATION ON THE IMPACT OF AIR POLLUTION ON SPERM HEALTH, MATERNAL HEALTH, FERTILITY, PREGNANCY AND BIRTH AND OTHER RELATED TOPICS. THE COMMUNITY SESSION INCREASED PUBLIC AWARENESS OF THE ISSUES INVOLVED. MANY POLITICAL LEADERS IN THE SALT LAKE VALLEY ATTENDED. AS A RESULT, THE CAMPION FUND PRESIDENT WAS INVITED TO ATTEND THE UTAH LEGISLATURE CLEAN AIR CAUCUS MEETINGS AS AN INTERESTED OBSERVER. THE CAMPION FUND PUBLISHED MONTHLY EDUCATIONAL BLOGS ON TOPICS PERTAINING TO REPRODUCTIVE SCIENCE, AND EMPHASIZED IN A SERIES OF FIVE BLOGS THE IMPACT AIR POLLUTION HAS ON REPRODUCTIVE HEALTH. THESE BLOGS CONTINUE TO BE ACCESSED BY A GROWING INTERNATIONAL AUDIENCE.
