Created know-your-rights, Rapid Response curriculums, trained over 800 verifiers and built 20 rapid response community teams. Work with undocumented folks between the ages 14-28 and provide volunteer opportunities, fellowships, internships, and leadership roles for youth. The hotline averages 900 calls per month, including text messages in 5 languages. Hosted 100 youth at a statewide gathering. There are now 10 youth groups working for migrant justice. Colectiva Legal charges a 10% admin fee on all funds raised to cover admin expenses.
