

A majority of the board of directors of this corporation (as required in the original Articles of Incorporation) has adopted these amendments to the Articles of Incorporation of this corporation.

RESOLVED, that the Articles of Incorporation of SWINGS FOR SCREENS, INC., now known as ARKANSAS UROLOGY FOUNDATION, INC., shall be amended with new Paragraphs FIRST and FOURTH to read as follows:

FIRST: The name of this corporation shall be "ARKANSAS UROLOGY FOUNDATION, INC." ("Corporation").

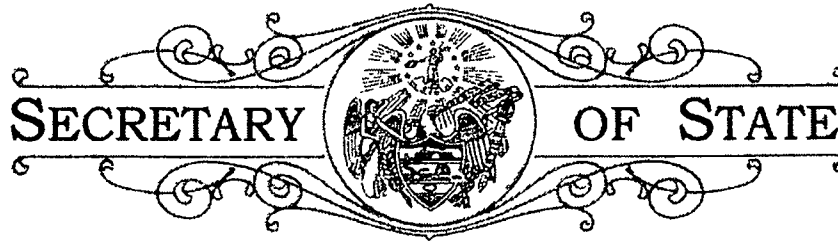
