This program includes custom designed group fitness exercise three-times a week, weekly support groups with fellow EXTRA-TOUGHS to address successes and challenges together and weekly nutrition classes to learn healthy eating habits. In 2019, the EXTRA-TOUGHS had four 12-week cycles with a total of 7 new starts to the program and 13 returning ladies. Thanks to generous grant funding from the State of Alaska Comprehensive Cancer Control, Let Every Woman Know expanded the EXTRA-TOUGHS program to the valley. Four 12-week cohorts will be held at AKtive Body Gym in Palmer from July 2019-June 2020. The first two cohorts in 2019 had 4 participants.
