THE JP OPOID INTERACTION AWARENESS ALLIANCE (FORMERLY THE JP PRESCRIPTION DRUG AWARENESS FOUNDATION) HAS BEEN ORGANIZED TO: 1) PROMOTE AWARENESS AND EDUCATION OF ACCIDENTAL PRESCRIPTION DRUG OVERDOSES. IT IS OUR DESIRE TO EDUCATE AND RAISE AWARENESS WITH CHILDREN, PARENTS AND THE MEDICAL COMMUNITY. THERE IS AN EPIDEMIC OF ACCIDENTAL PRESCRIPTION DRUG OVERDOSES THAT IS NOT WIDELY KNOWN.
