28 Performance Division: In 2019, Chamber Music OC presented a total of seven public concerts, most included or featured young musicians from the Pre-College Program. These concerts took place at venues such as the Irvine Barclay Theater, The Nixon Presidential Library and Museum, The Dorothy Doornbos Memorial Chapel in Riverside, and The Church of the Epiphany in Oak Park. Philippe Graffin, world-renowned violinist and pedagogue, was one of the featured Guest Artists in 2019. The members of Trio-Cleste, Chamber Music OCs Ensemble-in-Residence, performed in many of these concerts as well. Education Division: In 2019, the Chamber Music Pre-College Program held 44 days of classes in the spring semester, and 26 days of classes in the fall semester. There were 14 students in the spring semester, and 30 in the fall semester. 93% of the students in the program receive scholarship or financial assistance. All of them receive weekly coaching, classes, and career guidance. Over the course of the program, they perform for Guest Artists in master class settings, and in one or more public performances. Community Outreach Division: In 2019, Chamber Music OCs Community Outreach included visits to the Community Cultural Center in Irvine, the Rejoice Center, and OCASA. It is Chamber Music OCs goal to make the benefits of music more widely accessible and approachable for our community.
