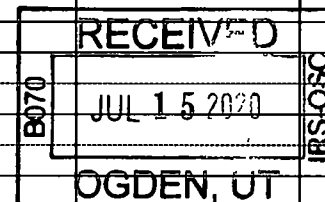

DURING 2019, THREE CHECKS WERE WRITTEN OUT OF THE FOUNDATION'S BANK ACCOUNT ERRONEOUSLY. THEY SHOULD HAVE BEEN WRITTEN OUT OF ANOTHER ACCOUNT OWNED BY A DISQUALIFIED PERSON. THE ERROR WAS DISCOVERED AFTER THE END OF THE YEAR, AND THE AMOUNT HAS ALREADY BEEN REIMBURSED TO THE FOUNDATION. ALTHOUGH THIS MAY TECHNICALLY CONSITUTE AN ACT OF SELF-DEALING, THE FOUNDATION WAS FORMERLY CLASSIFIED AS A PUBLIC CHARITY AND THEREFORE THE TRANSITION RULE PROVIDED FOR IN TREASURY REGULATIONS 1.170A-9(F)(4)(VII)(B) MEANS THAT THE FOUNDATION IS NOT SUBJECT TO THE TAX UNDER SECTION 4941 FOR 2019 AS IT REPRESENTS THE FOUNDATION'S FIRST YEAR BEING RECLASSIFIED AS A PRIVATE FOUNDATION.
