It is very rewarding to be a part of such a wonderful organization and team of dedicated volunteers. Free services:* 3,919 people follow the IR Blog* 13,335 people like the public IR Facebook page* 1,644 people have joined our controlled access IR Facebook Group* We now have posted 360 informative blog posts. Other IR social media channels include Vimeo, Twitter, LinkedIn, Pinterest, and Instagram. We do extra research and translations as requested and charge for these mission related program services when appropriate. Icelandic Roots Database:* We have 544 paid subscribers to the online IR Database, which is one of our primary program offerings.* The total number of individual person genealogical records in our database is now 679,866.* The database also contains 2,080 sources, 16,597 media items, 1,403 cemeteries, and 551,547 notes. 38 major volunteers take care of many items:IT, Genealogy, History, Cartography, Translations, Photos, Social Media, and special features. 25 of these volunteers do most of the work and are part of our SHARED email inbox, in which we received 15,755 emails in 2019. This does not include communications sent to us via other channels. We have an awesome IT team who maintain the genealogy database with security and cutting-edge software. They also keep our public website updated with fresh content. There was \$82,862 in membership/subscription income and \$21,006 in mission related grants and scholarships to worthy organizations and individuals. This does not count minor giveaways and promo items at various events in Canada, USA and Iceland. Our mapping expert completed a custom, interactive map of ancestral Icelandic farms in support of the centennial celebration tour for the Icelandic National League of North America. Formal IR speaking and educational events in 2019 included:- Sons of Norway Lodge in Fergus Falls, MN- Icelandic Roots Team Presentation at Icelandic National League of North America centennial convention in Winnipeg, Manitoba, Canada. Twenty IR volunteers attended the event- Orientation briefings to Snorri, Snorri West and Snorri Deaf cultural exchange program participants- Greeting remarks at annual August the Deuce heritage festival in Mountain, ND; annual Scandinavian Hostfest in Minot, ND; Fargo-Moorhead Icelandic Klub Christmas party in Fargo, ND; and Icelandic National League of Iceland annual convention in Reykjavik, Iceland- Information booth at Manassas Viking Fest in Manassas, VA- Provided a multi-day Icelandic genealogy center at the August the Deuce - Mountain, ND- One day genealogy seminars by IR volunteers in Egilsstadir, Iceland; Akureyri, Iceland; Gimli, Manitoba, Canada; and Winnipeg, Manitoba, Canada- Presentations on Icelandic culture and traditions to numerous elementary school class groups in North Dakota- Submitted numerous articles for reference and publication to Logberg-Heimskringla newspaper in Manitoba, Canada Also, our President and other principal volunteers continuously work to tell the Icelandic Roots story wherever they travel throughout Iceland and North America in order to educate and to preserve Icelandic culture, heritage, genealogy, and language.Our President was honored to receive the Knights Cross of the Icelandic Order of the Falcon in Iceland in August of 2017.
