

ExtraFood uses financial gifts wisely and efficiently: Every \$1 invested enables ExtraFood to share \$4 worth of Marin's fresh food with people in need. In 2019, ExtraFood's sixth year of operation, ExtraFood made significant progress toward its first major goal: Enrolling every possible Marin business and school in its program, and rescuing every available pound of excess fresh food for Marin's most vulnerable people. In partnership with so many across the county, ExtraFood's work in 2019 was another major step toward the day when all in our community have the food they need.</p>
