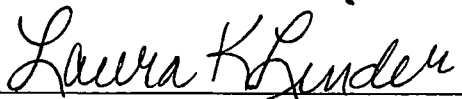

2. The new name of the Corporation following filing of the Articles of Amendment to its Charter shall be: **Wendy and Avron Fogelman Foundation**.
3. The above referenced name change is the only Amendment to the Nonprofit Corporation Charter. The Amendment is to be effective upon filing by the Tennessee Secretary of State.
