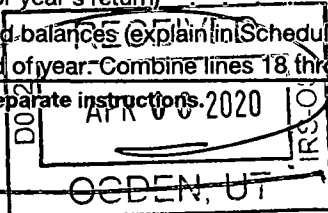

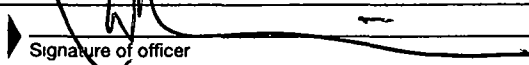

Volunteers have spent on average 80 hours per year on demolition and maintenance and repairs. The finished project will benefit the local community of 1,700 residents as well as neighboring communities with populations in excess of 28,000 residents. In addition, travelers and tourists who pass through the area on the National Scenic Byways Highway 17 will have an additional destination to enjoy in the James Arts and Natural Science Discovery Center.

Line 29 NCEF (continued) ... beauty of the Lower Grand Coulee. Impact: Ten individual grants of \$300 each were offered one time to 6 school districts comprising 35 schools and approximately 12,770 students. Progress: Teachers from 3 schools have been awarded 3 individual grants in service of about 75 students.

Line 30 Beauty of Bronze (continued) ... Kevin Patelle, renowned Northwest Bronze Artist has been our artistic guide from the beginning. The resulting art is observed by all in a gallery or museum after each piece is cast.

Line 31 Other Programs Arts/Education: Masquers Performing Arts scholarships \$750 awarded to 10 outstanding young people, ages 12-18 for their summer camp. There were 35 participants and eleven Masquers volunteers who presented a play on stage after three days in production, lighting and rehearsal. We may underwrite the complete program in 2020. This was a chance to welcome these aspiring young people to have a Theater experience in a state of the art facility.

Arts/Education: Gultar program sponsorship \$500 - this program came to Soap Lake in the Fall of 2018, a series of five programs over eight months. This group of performers were on a circuit including Ellensburg, and approached our local glass artist, Debbie Noah, about utilizing her Studio and Gallery as a venue. Along with donations from businesses and audience we can provide a cultural experience.

Soap Lake: Street Amenities \$254. FLGC has been working as a volunteer organization to lend expertise and man power for the term and ongoing maintenance of the City of Soap Lake's Main Avenue redevelopment. Beginning with planning assistance for the realignment of Main Avenue including sidewalk and planting design through implementation and continued maintenance. Over the past 7 years FLGC has spent over 300 hours in planning and design services, presentations and tours. On average 300 hours per year on planting and plant maintenance between Board and additional volunteers. The finished project has benefited the local business community as well as the local community of 1700 on a daily basis and in addition travelers and tourists who pass through the area on the National Scenic Byways Highway 17 who stop to enjoy city services and the James Discovery Center in the heart of this redevelopment.
