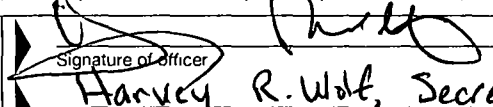

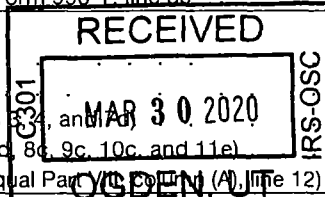

 Girl Up Initiative Uganda (GUIU) aims to build a vibrant movement of girls through transformative leadership, sexual and reproductive health education, and skills development. The organization envisions a gender equal world where girls thrive and lead. While adolescent girls and young women constitute our focus group, our approach engages boys and men as well, as this is key to bringing about gender transformation. The US organization's primary purpose is to provide funding for the Ugandan organization.

 The Adolescent Girls Program (AGP) reached a total of 2,146 adolescent girls and boys, parents, and teachers in 2019. The program empowers in-school adolescent girls to be leaders, reach their full educational potentials, and make healthy and informed choices. The AGP provides girls with the skills, knowledge, tools, mentorship, and support to develop their self-confidence and voice to thrive as leaders in their schools and communities. Program services include: year-long life skills, leadership, and sexual health trainings, school scholarships, teachers' trainings, parents' meetings, Boy Champions training sessions, advocacy events, and counseling and emergency support.

4b (Code) (Expenses \$ 66,034 including grants of \$ 60,830) (Revenue \$)
 The Big Sisters Network ensures that AGP alumni continue to stay involved and engaged after they have graduated from the training program. The network offers the space, environment, and time for emerging girl leaders to build their self-confidence positively, transform their lives and communities through knowledge, leadership, and skills building. In 2019, 210 girls were served through the Big Sisters Network through their participation in a four-day residential Big Sister Camp 2019 from May 7-10, 2019. After the camp, the girls were supported in conducting school and community outreaches and service projects.

4c (Code) (Expenses \$ 52,296 including grants of \$ 47,094) (Revenue \$)
 Mazuri Designs Hub aims to enhance the economic empowerment of young women through a vocational training course in fashion design, and tailoring that is combined with entrepreneurial and personal skills training for out-of-school vulnerable young women, ages 16-35 years. During the course of the Mazuri Designs Hub, participants learn practical, personal and business skills, with sessions on sewing, design, business and entrepreneurship, sexual and reproductive health, and social skills to build their confidence, improve their overall wellbeing, and create employment opportunities. 48 young women directly benefited from the Mazuri Designs Hub in 2019.

The organization re-named the Young Women's Economic Empowerment Program (YWEEN) to Mazuri Designs Hub to reflect the changes in how it conducts economic empowerment programming. All services were combined into one so that women in the vocational training also benefit from business trainings. Likewise, there is no separate program for business trainings for entrepreneurs.
