28 The year 2019 was once again filled with program service accomplishments. Twelve program events were hosted by the Foundation for 2019. Partnerships continued to be developed throughout the tri-state communities we serve. The 3rd annual Tractor Show, Rodeo, and Drive attracted over 150 participants and attendees to our small rural community. The 5th annual Spring Dundy Roo Arts and Crafts Festival at the Cornerstone Center for Community Service brought over 400 people to Haigler (population more than tripled). In partnership with the Nebraska Arts Council, and the Museum of Nebraska Art, the Foundation was able to bring two outstanding art exhibitions to be displayed at the Cornerstone Center for the Festival and remaining on display until mid July. These exhibitions were Joel Sartore, National Geographic Photo Ark and Nebraska--Its Land and Its People. The Foundation also help host the Ducks Unlimited Banquet, and conducted Bunny Bag Sales at the Sunshine Thrift Store at the Cornerstone Center. Memorial weekend and many Alumni events that weekend kept the Foundation volunteers busy with activities and open houses. The Foundation participated in the 1st annual Car Show held on Main Street in Haigler. Over 200 participated in this event. In June, the Foundation participated in the Nebraska Cattleman's Ball and had several Haigler Museum exhibits on display in the history tent for this event. Several thousand Nebraskans attended this weekend event in a nearby county of southwest Nebraska. The traditional 4th of July fireworks display and icecream sundaes was well attended with over 200 people. In August, the Foundation once again hosted the annual Haigler Summer Music Festival in the Park. Working with the Nebraska Arts Council, the well known Toasted Ponies musical performance group and the local Old Time Pickers performed for over 500 attendees. Local church groups provided meals, homemade pies and icecream. This event was supported by community businesses and individual sponsors as well as the Haigler Community Foundation hosting. In October, the Foundation was an integral participant for southwest Nebraska to join the Trail of Treasures (garage sales across all of southern Nebraska). And, later in October, the Foundation hosted on the Haigler Museum grounds the 12th annual Fall Tumbleweed Festival with live music, games, food, and open house in all the museums. November saw the very popular Haigler Gun and Craft Show return for the 6th year- held at the Cornerstone Center for Community Service. This weekend event brought over 500 attendees to our small community. and in December, the annual winter holiday activities and open house hosted by the Haigler Community Foundation. The Foundation continues to work with our Dundy County Tourism, the southwest Nebraska Tourism, and the Nebraska State Tourism to develop the former Conoco Station Museum into a state tourist visitor center along Highway 34--the Golden Rod Highway.
