In 2019, Dear World completed a partnership with the V Foundation for Cancer Research on an inspiration video called "Dear Victory." In this video, played at the 2019 ESPY awards on ESPN, legendary college basketball figures Mike Krzyzewski (Duke University) and Dike Vitale (ESPN) pen a letter to their friend Jim Valvano, the namesake of the V Foundation. In 2019, Dear World also traveled to Varanasi, India the holiest Hindu city in the world. While in India, Dear World interviewed women from the Untouchable caste whose families tend to the 2,000 year old cremation pits. This series is entitled "Last Words from Varanasi." Finally, Dear World partnered with the Harvard Divinity School and its conference: "Reimagining Happiness for a Better World." We visited Bhutan to understand and learn more about the concept of Gross National Happiness and what that means to the Bhutanese people. The final product was a short film presented at the Happiness Conference on Harvard's
